REQUISITOS PREVIOS / PREREQUISITES

Students should have completed satisfactorily all the courses of the first and second semesters, including the Practicum.

OBJETIVOS / OBJECTIVES

The master's thesis is a carefully argued scholarly paper. It should present an original argument that is carefully documented from primary and/or secondary sources. The thesis must have a substantial research component and must be written under the guidance of a supervisor.

As the final element in the Degree, the thesis:

- gives the student an opportunity to demonstrate expertise in the chosen research area;
- guides the student in the process of publicly defending a piece of research;
- prepares the student for independent research at doctoral level.

COMPETENCIAS / COMPETENCIES

Competence in the elaboration and public oral defence of a piece of research.

Acquaintance with the latest trends and research methodologies in the various fields of English Studies: English language and linguistics (theoretical and applied), Anglophone literatures and cultures.

CONTENIDOS / CONTENTS

Contents will be determined by the topic and research project chosen by the student and his/her supervisor.

The Master Thesis must be written in English.

- **Length and formal characteristics:**

Between 10,000 and 14,000 words maximum (40-60 pages approximately, double spaced).

12-point Arial font or Times New Roman.

Please note that **included in the above specifications** are the title page, abstract (if any), table of contents, contents proper, acknowledgements, reference list, and appendices.

The MA Thesis will include a statutory declaration of originality (signed and dated) on its second page (template for guidance provided below in italics)

METODOLOGÍA / TEACHING METHODOLOGY

The student will meet for tutorials with his/her supervisor to receive feedback on the topic, contents, structure and bibliographical references recommended for the research project. The supervisor will be regularly informed about the progress and development of the project.
